 - a) Budget Report
 - Mrs. Johnson stated the following:
 - Enrollment is at 143, ADM is 135.
 - Small School Adjustment:
 - Met with Darren and Judy Simmons to explain the enrollment situation to them. Mr. Simmons needs to know in case this has to go before the County Board of Supervisors.
 - Met with Tom Hurt and Elizabeth Valenzuela. They are researching to see at what point taxes can be frozen.

b) Budget Report

- Mrs. Johnson stated the following:
 - We are finalizing the big Renovation Project to close out the project with SFD.
 - There are a few areas that do not line up between bond funds and SFD funds. It appears that some of the administration fees were overcharged to the bond when they should have been charged to SFD. This put the bond account in the negative and left money on the table for SFD.
 - We are closing out all of the FY24 Grants and making sure FY25 Grants are open and approved so money can be drawn down.

c) Academic Report

- Mrs. Johnson stated the following:
 - September 16th will be a PD day with teachers and staff.
 - We had a lockdown drill today. Correspondence was sent home informing parents on what to do in case a lockdown is necessary.
 - The Book Fair is going on at this time.

d) Facilities Report

- Mrs. Johnson stated the following:
 - The housing plumbing and roofing project is complete.
 - Now the septic and septic lines need to be replaced in housing. We have contingency money, and balance in housing. We are waiting for a quote.
 - The new warmer for the cafeteria has arrived. The old one caught on fire.
 - The Gym HVAC project should begin soon. We are waiting for approval from SFD. The project is just under \$100,000.

e) Water Plant Report

Mrs. Johnson stated the following:

- Continuing to take measures to study TTHM and try various techniques to address the high TTHM issues.
- We are seeking to use a sodium permanganate but it appears that this adds points to our classification on the system.
- There are solutions but many of them add points to our system, which would make it a "Grade 3."

 - The final voters pamphlet for the M&O Override is done.
 - We created a Q & A document. The public needs to understand that this is not a new tax but a continuation of the last override.
 - Mrs. Johnson will be attending the Arizona Rural School Association conference October 1-3, 2024, then after that, she will out on personal leave, October 7-9, 2024.
 - The ASBA County Meeting will be on Thursday, September 26, 2024. No board members will be attending, but Mrs. Johnson will attend.
